1. TERMS OF OFFICE:

(1). Each member shall hold office for three years or till he/she hold the office of the post or remain a member of the Trade Union or Organisation he/she represents as the case may be whichever is earlier.

(2). Where the appointment of the successor of any such member has not been notified by the Government on or before the expiry of the said period of three years, such member shall continue to hold such office until notified by the Government in the Official Gazette.

(3) The Board shall meet at such time and place and observe such rules or procedure in regards to the transaction of business at its meeting as may be prescribed.

(4). The Chairperson, if, for any reason, is unable to attend a meeting of the Board, any member nominated by the Chairperson in this behalf and in the absence of such nomination, any member elected by the member present from amongst themselves at the meeting, shall preside at the meeting.

(5). Any question which come up before any meeting of the Board shall be decided by a majority of votes of the members present and voting, and in the event of equality of votes, the Chairperson or in his/her absence, the person presiding, shall have a second or a casting vote.

2. FUNCTIONS OF THE BOARD:

(1). The Board may –

(a) provide immediate assistance to a beneficiary in case of accident;

(b) make payment of pension the beneficiaries who have completed the age of sixty years;

(c) sanction loans and advances to a beneficiary for construction of a house, not exceeding such amount and on such term and conditions as may be prescribed;

(d) pay such amount in connection with premia for Group Insurance Scheme of the beneficiaries as it may deem fit;

(e) give such financial assistance for the education of children of the beneficiaries as may be prescribed;

(f) meet such medical expenses for treatment of major ailments of a beneficiary or such dependant, as may be prescribed;

(g) make payment of maternity benefit to the female beneficiaries; and

(h) make provision and improvement of such other welfare measures and facilities as may be prescribed.

(2). The Board may grant loan or subsidy to a local authority or an employer as may be approved by the State Government towards welfare of building workers.


(3). The Board may also pay grant-in-aid to a local authority or to an employer for the benefit of the building workers and their family members, subject to limit as may be prescribed by the State Government.

The other terms and conditions of the Mizoram Building and other Construction Workers Board shall be as prescribed by the Building and other Reconstruction Workers (Regulation of Employment and Conditions of Service) Act, 1996.
